And, while each conception certainly finds a place in each of the three countries under examination, there is an important sense in which individualist conceptions have dominated much of the American jurisprudence, communal approaches have influenced a great deal of the Canadian case-law, and federalist conceptions have shaped the Australian cases at a number of decisive points. The article concludes by arguing that, although factors such as modalities of interpretation and conceptions of the relationship between the courts and the political branches of government have been important, significantly different underlying conceptions of democracy and of the political identity of the human person have, in a fundamental sense, been ultimately determinative of the results.
